# McHenry Outdoor Flea Market

## Vendor "Rules and Regulations"

**Sunday, May 30<sup>th</sup>, June 27<sup>th</sup>, July 25<sup>th</sup>, August 29<sup>th</sup>, September 26<sup>th</sup>, 2010**

1. McHenry Outdoor Flea Market reserves the right to refuse admission or remove any Vendor from the premises. Vendors may not sub-lease any part of their selling space. There is no refund for Vendors or switching to a later date.
2. All pre-registered Vendors must check-in at the gate before 7:30 am to guarantee their reserved spot. Vendors arriving after 7:30 am may be relocated if another spot is open.
3. The sale of any item prohibited by any city, town, country, state or federal law is strictly prohibited. No fireworks, guns, drug related paraphernalia, used mattresses or otherwise flammable or dangerous will be permitted on the property.
4. The McHenry Outdoor Flea Market is a family oriented market and therefore there is to be **NO** pornographic or "X" rated material permitted on the premises.
5. The sale of any counterfeit merchandise or merchandise which violates trademarks and copyrights of others is prohibited.
6. The sale of food and beverages by any Vendor is **STRICTLY PROHIBITED**. Concessions will be available.
7. In the event of inclement weather, no rain checks will be issued. The McHenry Outdoor Flea Market will be open **Rain or Shine** and is in no way responsible for any damage done to your merchandise due to the weather. Please note, that as a courtesy to those who pay to attend the McHenry Outdoor Flea Market we would like to provide them with a wide variety of Vendors and therefore; **ANY VENDOR LEAVING BEFORE 3:00 P.M. WILL BE CHARGED A FEE OF \$50.00.**
8. Portable canopies are recommended, but have a minimum of 50 lbs. on each vertical pole for wind control. No nails, stakes or other objects may be driven into the ground.
9. **NO** animals are allowed on the premises.
10. **NO** political material may be distributed. The use of any loud speakers, bullhorns, or jamming devices is prohibited. Any TV or radios etc. must be kept to a level which does not disturb others.
11. Vendors will receive their permits at the gate on the day of the event. These permits must be displayed and available for inspection. **NO** selling outside of vendors rented space will be allowed. All aisles must be kept clear of merchandise and/or vehicles. Vendors are allowed only one (1) vehicle or trailer to be parked in the back of their selling space; all other vehicles and trailers must park in the designated vendor parking area. If you need more than one vehicle in your space we recommend purchasing more than one space. Vendors are allowed one additional free general admission at check-in. All others will have to pay the General Admission price.
12. Vendors must conduct themselves in an appropriate and orderly manner.
13. The Vendors **MUST KEEP THEIR SELLING AREA CLEAN**. Any Vendors leaving excessive garbage will be charged a \$100.00 fee. We will record vendor license plates so as to contact any vendor violating this rule. Vendors agree to a cleanup charge and the possibility of not being allowed to sell at the McHenry Outdoor Flea Market in the future. **ALL EXCESS GARBAGE MUST BE TAKEN WITH YOU!**
14. All Vendors are subject to the Illinois Retailer's Occupation Tax. Forms are available at the Main Gate. You can contact the Illinois Department of Revenue's Special Events Department at (847) 294-4475 or at [www.tax.illinois.gov](http://www.tax.illinois.gov) with any questions. The Illinois Department of Revenue requires us to report all Vendors that participate in the McHenry Outdoor Flea Market.
15. Vendors agree to indemnify against and hold harmless McHenry Outdoor Flea Market, McHenry Outdoor Theatre, "C" You At The Movies, Inc., Rhyon Holdings, LLC. And McHenry County harmless from any and all claims (including the cost of defense of any claim) resulting from The vendors actions on the property. Vendors shall supervise and control activities of all their employees, agents and/or helpers and will be responsible for their actions.

VIOLATIONS OF ANY OF THESE RULES MAY RESULT IN IMMEDIATE REMOVAL FROM THE McHENRY OUTDOOR FLEA MARKET.
